## Clinical Information – *When and where required*

Imagine this: A patient comes into your facility with an acute episode of asthma. At the clinicians' fingertips is an order set that not only is based on best practice but has links to the evidence that informs this care. As the order set is completed other members of the team are notified of the actions required so the care can be timely and coordinated. That is just one example of what clinicians will be able to do when the Clinical and Systems Transformation Project is fully implemented within VCH, PHC and PHSA.

Demonstrations of the new Clinical Information System (Cerner) have been arranged for staff and physicians. This will provide an opportunity to gain an initial or deeper understanding of some of the future capabilities that we will be designing through the Clinical and Systems Transformation Project.

### **Question of the Week**

#### ***Does Cerner have adequate capacity to handle all our order set requirements?***

A review is underway to understand the requirements for clinical protocols and order sets. Cerner has the capability to handle it all and the CST Project Team is aware of the complexity. Clinical Design Teams will review requirements and ensure processes and systems meet the needs of all health organizations

### **Leveraging Lessons Learned**

One industry-proven tool being considered by the CST Project Team is Zynx, a commercially available, evidence-based order set content management tool. It offers a starter set of evidence-based content and has been adapted to the Canadian health system by Cerner users in Ontario. Clinicians will leverage this existing work rather than create content from scratch.
